John Marek, with Anson Economic Development Partnership spoke to the Council about the industrial tax grant incentive for Project Hoist.

An existing company in Wadesboro is planning to add an assembly line for a new type of product. The company is planning to begin the project in 2018. The project will create 20 new jobs. The company is asking a tax grant incentive from the Town of Wadesboro in the amount of \$92,340.
