## TOWN OF WADESBORO REGULAR TOWN COUNCIL MEETING APRIL 3, 2017

Council members present: John Ballard, Fred Davis, Bobby Usrey and James David Lee. Town Attorney, Aaron Bates was present. Mayor Bill Thacker and Councilman Jeremy Burr were absent.

Mayor Pro Tem James David Lee called the meeting to order and presided.

Bobby Usrey made a motion and Fred Davis seconded to approve the agenda. Approved by a vote of 4 for and 0 against.
